

Rs 400.24 crore crop insurance approved for kharif, rabi season 2023 in Beed: Minister

Mumbai, Aug 13 (UNI): Agriculture Minister Dhansraj Munde announced on Tuesday that crop insurance worth Rs 400.24 crore has been sanctioned so far in Kharif and rabi seasons of 2023-24 in Beed district.

During a joint meeting of the chief officers and officers of Indian Agricultural Insurance Company here, he said that out of that amount, Rs 378.21 crore has been disbursed to the bank accounts of concerned farmers till date.

He expressed his displeasure over rejection of insurance applications of some farmers in the revenue boards of some talukas without giving any reason and directed the crop insurance company to approve these insurance applications and complete the process of distribution of the remaining Rs 22.03 crore by August 31.

Munde has instructed the Director of Agriculture to review both these processes on a daily basis and update the minister's office about the same.

The minister warned that criminal cases will be filed against the insurance company if farmers are denied crop insurance without giving any reason.

Delhi LG nominates Gahlot to hoist flag on I-Day

"The tricolour is hoisted on August 15 to represent democracy, freedom, and the voice of the people of India. However, today, the right of an elected government to hoist the flag is being snatched away, as if a new viceroys has arrived in Delhi, claiming the authority to hoist the flag," Atishi asserted.

NCP-AP to undertake Constitution reading activity on Aug 15

Mumbai, Aug 13 (UNI): The NCP-AP will undertake a campaign of the reading of the Preamble to the Constitution in the party offices across Maharashtra on August 15, in order to reaffirm their belief in the supreme law of the country.

Addressing a press conference here on Tuesday, NCP state president and MP Sunil Tankare said that on behalf of NCP-AP, the 'Constitution Reading' activity will be conducted in entire Maharashtra at the party's head office and district offices after hoisting the national flag. He further said that they

have decided to conduct this campaign because a question was raised about the Constitution during the Lok Sabha election. He said that in the party manifesto for the Lok Sabha election, they had printed the Preamble to the Constitution on its first page.

"We are moving politically by believing in the ideology of Chhatrapati Shivraji Maharaj, Chhatrapati Shaahu Maharaj, Yashwantrao Chavan, and Dr B.R. Ambedkar," he said. Asserting that the Constitution is the soul of the country, NCP-AP chief said that it is because of

this belief that they are going to carry out such a campaign in the state.

"We Indians love the Constitution and that is why we will hold the community reading of the Constitution on August 15 under the leadership of Ajit Pawar, national president of NCP," he said.

"We will undertake various activities in order to strengthen the Constitution on this Independence Day," he added.

Asked about the Jan Samman Yatra, Tankare informed that the Yatra received an unprecedented huge response from the public.

GAD rejects Delhi CM's request for Atishi to hoist flag on I-Day

New Delhi, Aug 13 (UNI): Delhi General Administration Department (GAD) on Tuesday denied permission for Asim Admi Party (AAP) leader and Delhi Cabinet minister Atishi to hoist the flag on Independence Day 2024 in the absence of Chief Minister Arvind Kejriwal.

Minister Gopal Rai of the General Administration Department had written a letter to the Additional Chief Secretary of GAD yesterday, stating that he had met with Chief Minister Arvind Kejriwal. The Chief Minister wanted Atishi to hoist the flag at the August 15 ceremony, and preparations should be made accordingly.

In reply to his letter, the Additional Chief Secretary of GAD said, "It is absolutely clear that the above communication does not qualify in the permissible communication which can be sent outside prison. Only private correspondence with designated set of people as defined above is permissible. Therefore, any communication, written or oral, in contravention of the rules quoted above, is not legally valid and therefore cannot be acted upon." GAD sought concurrence of the Delhi Chief Minister for his availability for the Independence Day Function. However, office

of Chief Minister has indicated his non-availability being in judicial custody, the reply said.

"The issue has therefore, been brought to the kind notice of the higher authorities and the decision is awaited. General Administration along with all concerned Departments are making all arrangements for the Independence Day Function at Chhatrapati Stadium, as per past practice," it added.


