Textual Information(1)	The listed capital of the Company is 5,73,900 equity shares. Out of this, the promoters holding of 3,15,872 equity shares is already in demat form. The balance capital of 16,26,100 equity shares, issued on a preferential basis, is pending listing approval from BSE. It may be noted that for the purpose of dematerialisation of shares, the same are first required to be listed on BSE. Accordingly, the said preferential allotment of 16,26,100 equity shares can be dematerialised upon receipt of listing approval. The Company has made various submissions to BSE from time to time for revocation of suspension of trading and has also submitted an application for listing of the aforesaid pending equity shares along with the revocation application. We trust the above clarifies the position. We request your approval for listing of 16,26,100 equity shares issued on a preferential basis and for revocation of suspension of trading of the Companys shares.
